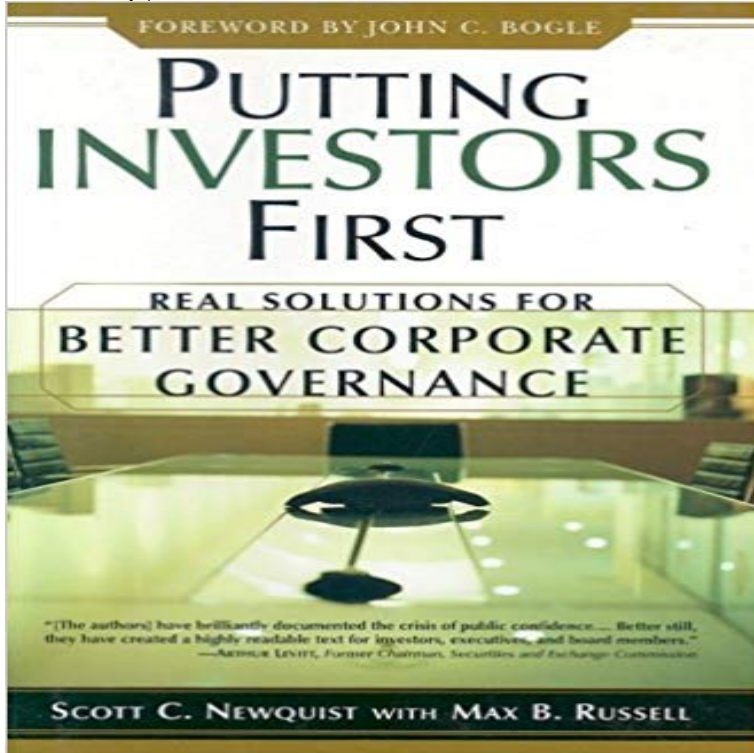


# Putting Investors First: Real Solutions for Better Corporate Governance
