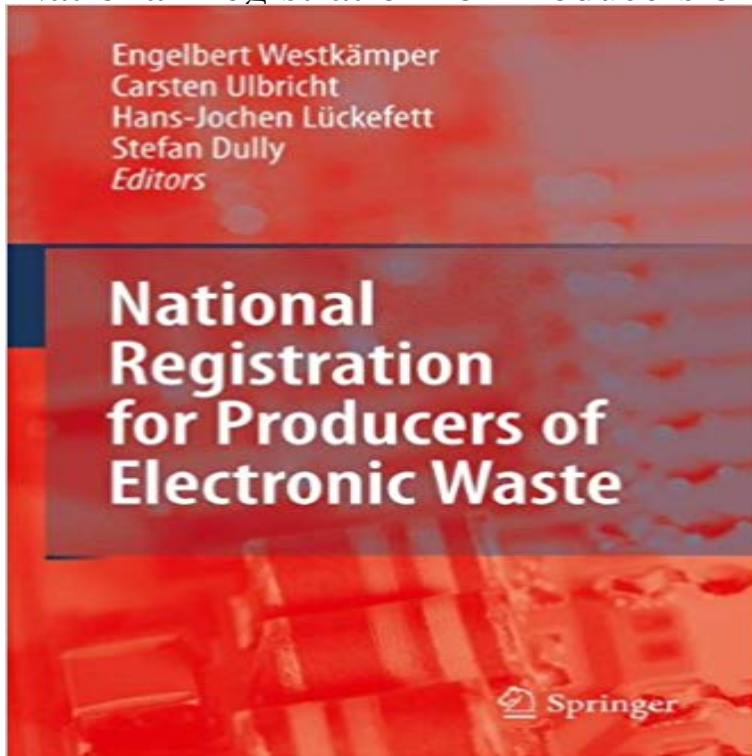


# National Registration for Producers of Electronic Waste
