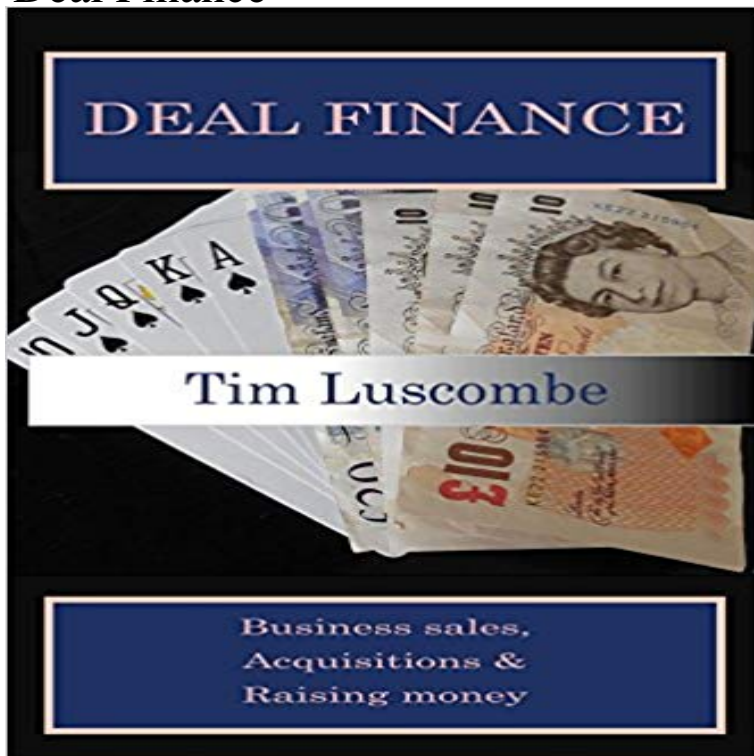


Deal Finance
