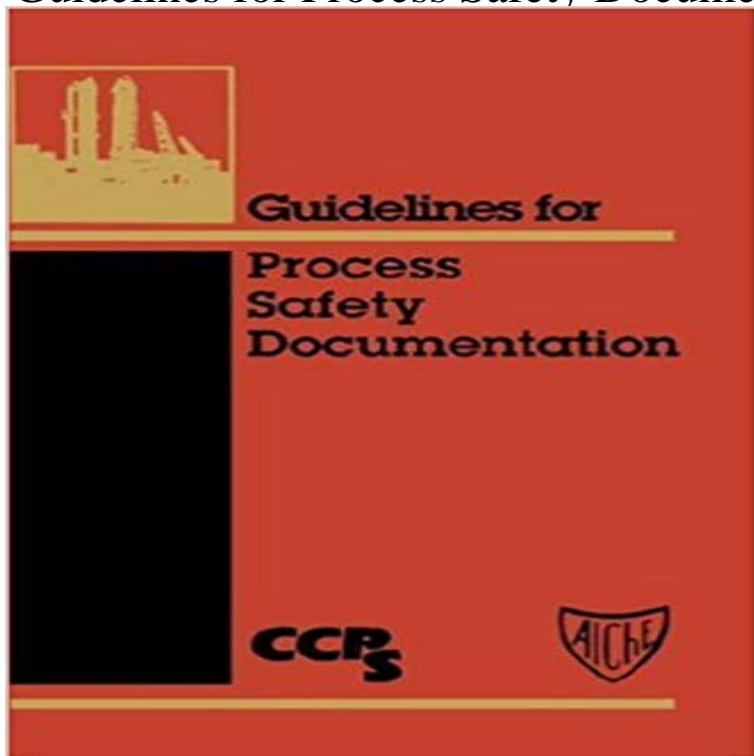


Guidelines for Process Safety Documentation
