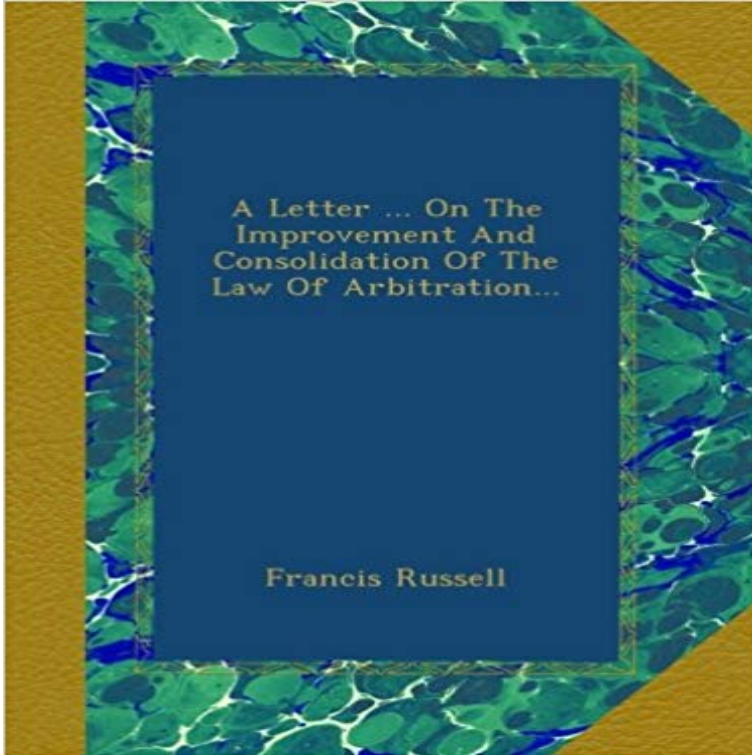


# A Letter ... On The Improvement And Consolidation Of The Law Of Arbitration...
