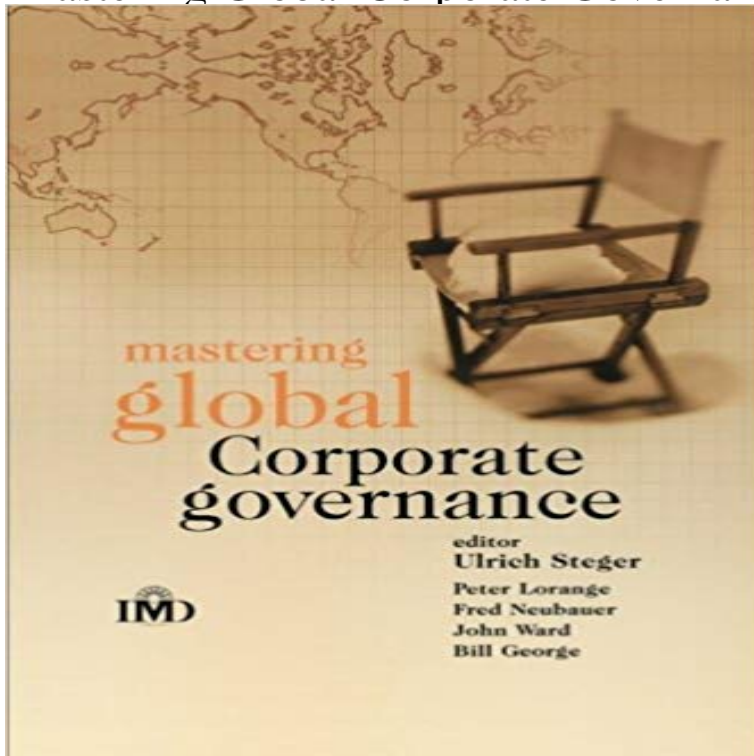


Mastering Global Corporate Governance
